AGENDA ITEM #2

Mayor Stegall stated that he informed that member that the council only agreed to allow this free event once a month and it was the responsibility of TCCC to make arrangements for the transport of items collected. Amanda L'Esperance stated that that issue had already been handled. Donna Thomason made the motion to allow Leon Hanson to work longer than his scheduled time if necessary. David Phillips seconded. Vote unanimous.

AGENDA ITEM #6


E. J. Cates made the motion to approve accounts payable. Donna Thomason seconded. David Phillips Abstained. Vote carried.
