Donna Thomason excused herself from the meeting to allow Allen Foster, the newly elected member, to assume duties.


Willie "Bear" Wilkins made the motion to re-appoint David Phillips as Mayor Pro-Tem. Allen Foster seconded. Vote unanimous.

David Phillips made the motion to adjourn. Willie "Bear" Wilkins seconded. Vote unanimous.


